



Campus Anywhere Cancellation and Refund Policies

All Campus Anywhere Locations:

Program Deposit	\$300; Due within 2 weeks of program acceptance, on or before application deadline; Non-refundable for all program locations; Cannot be deferred with financial aid
Withdrawal after acceptance but before the Application Deadline	Full Refund; Less: <ul style="list-style-type: none"> • \$300 Program Deposit
Withdrawal after the Application Deadline but before the Program Start Date	Full refund; Less: <ul style="list-style-type: none"> • \$300 Program Deposit • \$1,000 Cancellation Fee
Withdrawal on or after the Program Start Date	No Refund Guaranteed

Additional details about cancellation and withdrawal:

- Change of Program Dates: Amizade reserves the right to change the program dates if it is necessary. Affected students and their home institutions will be notified immediately by email of any change in program start date and will be advised on next steps and provided support. If the program dates change, students will not receive a refund or discount for missed days.
- Program Cancellation by Amizade: If Amizade cancels a program before the program start date, we will issue a full refund for the published Campus Anywhere program fee and the \$300 deposit. The “Program start date” means the published starting date of your program, as shown on the Campus Anywhere webpage. In lieu of a refund, participants may have the option to apply their refund amount as a credit toward a different or a future Amizade program. Affected participants and their home institutions will be notified immediately by email of any program cancellation, and Amizade will advise students on alternative options, such as switching to a different program location or deferring participation to a future term. We will assist students who wish to change locations or defer so that the transition is as seamless as possible in terms of steps and paperwork. If Amizade cancels a program on or after the program start date, we will issue a refund for recoverable expenses and assist and support affected participants in navigating next steps necessitated by program cancellation. However, we cannot guarantee that expenses will be recoverable, and the \$300 deposit is non-refundable.

- Withdrawal by the Participant or their Home Institution: If a participant withdraws participation, or if their home institution withdraws permission to participate in a program before the program start date, refunds will be according to the cancellation policy noted in the chart above. If a participant withdraws participation, or if their home institution withdraws permission to participate in a program on or after the Campus Anywhere program start date, we may be able to issue a refund for recoverable expenses. However, we cannot guarantee that expenses will be recoverable, and the \$300 deposit is non-refundable.
- COVID-19: Flexibility may be possible if the reason for withdrawal is being unable to travel due to the student being infected with or exposed to COVID-19, or other COVID-19 related extenuating circumstances that can be documented. Supporting documentation will be required. However, we cannot guarantee that expenses will be recoverable, and the \$300 deposit is non-refundable.
